

Schoolies 2022 Terms & Conditions

Please read the following Terms & Condition and sign the declaration below. Failure to observe and adhere to these rules will result in instant eviction from the Park and potentially ALL registered guests on your site:

- Valid Student ID cards must be presented on arrival.
- No illegal drugs permitted. Any persons found to be in the possession of drugs will be immediately reported to the Police and evicted from the Park.
- The following are not permitted in the Park; glass bottles or glassware, beer bong, nitrous oxide/"nangs". These items will be confiscated and returned on your departure.
- No visitors whatsoever allowed in the Park.
- Unruly or offensive behaviour will not be tolerated.
- Park employees reserve the right to inspect the sites and cabins at any time.
- The area outside the Park perimeter is a dry zone and will be policed. Fines may apply.
- No fires are permitted.
- Sites are to be kept free of waste/rubbish (rubbish bags are available at Reception).
- The Proprietor or his representative/s have the right to terminate occupancy or refuse entry to any persons.
- One car is allowed per site only. Only one car sticker will be issued. Access will not be permitted without the car sticker.
- All vehicles will be inspected on arrival and randomly thereafter for any items not permitted.
- A speed limit of 10 kms (walking pace) applies throughout the Park.

COVID-19 Regulations:

For the collective safety of school leavers and the wider community, anyone attending this year's Schoolies Festival™ will need to be up to date with their COVID-19 vaccinations. The decision was made based on advice received from SA Health and SA Police as Encounter Youth prepares to run a COVID-safe festival at Victor Harbor on 25-27 November 2022.

Please be aware: If the final payment is not made by the 19th October 2022 you will forfeit your Schoolies Festival Accommodation and Ticket Package with no refund for prior payments.

Bond Payments

It is the responsibility of the student Team Leader of the site/accommodation to arrange a refundable bond payment of; \$300 for sites, and \$600 for cabin bookings, to be paid **(in CASH only)** on arrival at the park. EFTPOS and credit card payments will NOT be accepted. Cash payments allow for a more efficient departure.

The bond will be held until departure and refunded to the student Team Leader upon departure, subject to a site/accommodation inspection by a park employee. Any damage to park property, and/or excess waste remaining on departure, will result in the bond being fully or partially withheld.

In the event the bond is withheld, an amount estimated to be the equivalent for repairs to damaged property and/or disposal of any waste, will be deducted. No disputes regarding bond refunds will be entered into.
